### **TOUR OPERATING ONLINE TRAINING COURSE**

Tourist Guide Institute is now offering tour operating, online training courses. At this stage there are no Cathsseta accredited tour operating courses, but there is a need for basic training to help tourist guides start their own tour operating businesses. The course was developed out of the mentorship program that TGI runs with our tourist guide students, who start their own tour operator businesses. As well as having the tourist guide training exposure, the staff at TGI are able to draw on their years of experience as tour operators, having owned and run All Africa Tours since 2006. The course co-ordinators are Scott Womack and Julie Womack.

### **Tour Operating**

#### **Entry requirement:**

- English language proficiency and computer literacy are essential
- Access to a computer and internet are mandatory
- Copy of Tourist Guide qualification if already qualified and registered.

#### Course setup:

- The course is made up of 8 main video topics viewed online
- Online tour operating handbook with interesting articals and activities that back up the video lecturs.
- The handbook also has space for the student to jot down ideas and reflections along the way.
- There are 3 formal assessment areas that are done at the end and handed in for feedback from TGI.
- On completion, the student will receive a certificate of competence and completion.
- Students work at their own pace.
